You Can Buy Without Flying In

Dubai's property process is digital, regulated and built for international buyers, so an overseas investor can complete a purchase without ever visiting. Documents can be signed remotely or through a power of attorney, payments flow through regulated channels and escrow, and the DLD title is issued without your physical presence. Thousands of investors buy this way each year; the key is doing it through trustworthy people and proper verification.

The Remote-Purchase Path

01 Define the brief and shortlist

01

Agree your goal, budget and criteria, then shortlist specific units, with video walk-throughs and full data rather than a site visit.

02 Reserve and review the contract

02

Place a reservation, then review the sale agreement (SPA for off-plan, MOU for resale); have a lawyer check it before you sign.

03 Sign remotely or via power of attorney

03

Sign documents remotely where allowed, or grant a verified power of attorney to a trusted representative to sign and complete on your behalf.

04 Pay through regulated channels

04

Funds move through regulated bank channels and, for off-plan, milestone-gated DLD escrow, never informally to an individual.

05 DLD transfer and title

05

The transfer completes at the DLD, in person by your representative or via the digital process, and the title deed is issued in your name.

INVESTOR TAKEAWAY

Remote buying follows the same regulated path as an in-person purchase, with a power of attorney bridging the few in-person steps. Done through proper channels, it is safe, common and straightforward.

DOING IT SAFELY

Protecting Yourself From Afar

WHAT TO DO

- + Use a verified, limited POA**
Grant a narrowly-scoped, properly notarised and attested power of attorney to a trusted representative, not an open-ended one.

- + Pay only through escrow/bank**
Off-plan funds belong in DLD escrow; never transfer to a personal account.

- + Verify everyone and everything**
Confirm the agent, developer, title and that the area is freehold before any money moves.

WHAT TO AVOID

- ! Informal payments**
Any request to pay an individual directly is a red flag; stop and verify.

- ! Skipping legal review**
Have the SPA or MOU reviewed before signing, even remotely.

- ! Over-broad authority**
Limit the power of attorney to the specific transaction and time frame.

INVESTOR TAKEAWAY

Remote buying is safe when the process is regulated and the people are verified. A narrow power of attorney, escrow-only payments and proper legal review let you buy confidently from anywhere in the world.
